Founded in 1970, NorthEast Treatment Centers (NET) offers support and hope to individuals and families at times of great stress in their lives. A nonprofit agency, NET provides a continuum of trauma informed behavioral health and social services designed to meet complex needs of all family members. These include mental health, addiction treatment, foster care, residential group care, adoption, juvenile justice services and child welfare services. While some services address the needs of the family as a whole and some target individuals, we always strive to foster positive connections within the family to help all family members heal, recover and rebuild.

YEAR IN REVIEW/HIGHLIGHTS

Commitment to Inclusion

This year, we deepened our commitment to cultural competency through staff training and community engagement. Our Annual Inclusion Week celebrated diversity across our workforce and communities, which highlighted resources for individuals with disabilities, and elevated the importance of self-advocacy.

Positive Recognitions

- Drop-In center funded by the Pennsylvania Department OF Drug and Alcohol Abuse Programs (DDAP). The center is designed to ensure people can access concrete resources and information to minimize the impact of using substances as individuals also consider treatment options.
- State Opioid Response (SOR) grant provides outreach and outpatient services in Delaware by veterans for veterans with substance use disorders.
- Wendys Wonderful Kids grant to provide targeted permanency support for older youth and children with specialized needs.
- William Penn Foundation Kinship Caregiver Support Grant provides kinship caregivers additional training, education, and coaching with a focus on early intervention.
- PCCD Violence Intervention & Prevention (VIP) Grant to provide after-school prosocial academic and cultural-enrichment programming to youth in North Philadelphia
- PACTT Youth Career Development (New Vision Program) to provide job training and career readiness for youth enrolled in Evening Report Center
- Continue to be a top-tier performer in Community Umbrella Agency's scoring system
- Received performance bonus for providing evidence-based programming

Partnerships and Community Engagement Efforts

- Hosted 100+ community events in North and Eastern North Philadelphia regions. These events serve to foster and strengthen neighborhood relationships to celebrate local culture and heritage. These also include health fairs, financial literacy sessions,

and resource days to connect families with important information, concrete goods, and resources

- Partner with Public Health Management Corporation (PHMC) to provide Highway safety school, CRN evaluations and D/A assessments
- Partnered with Access Matters as subcontractor to support HIV testing for high-risk youth (ages 18 to 24 and to engage youth in conversations about HIV, sexual behavior, and STI prevention.
- Received performance bonus for doing behavioral health screenings in the community.

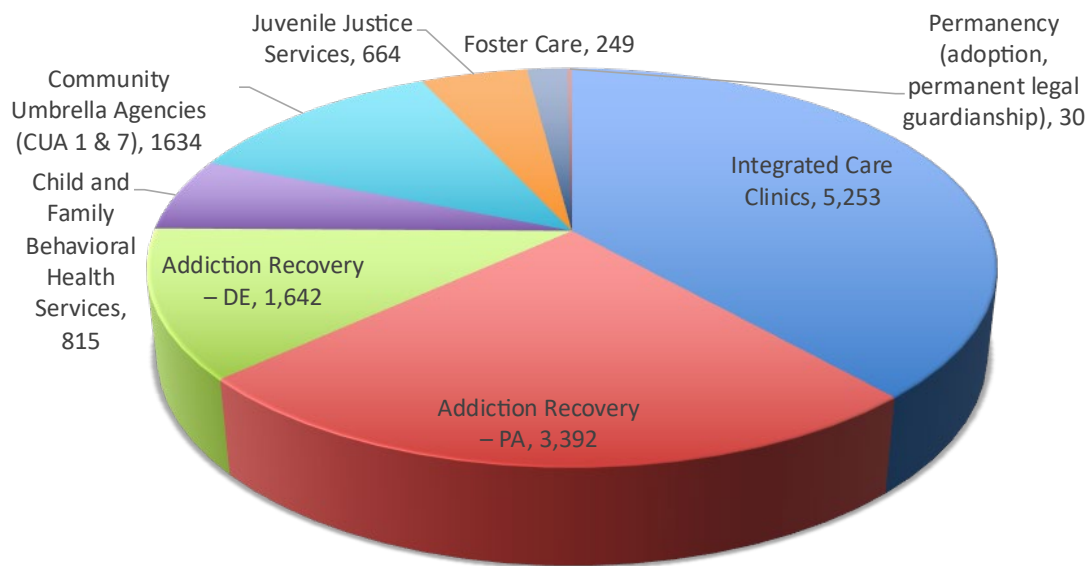

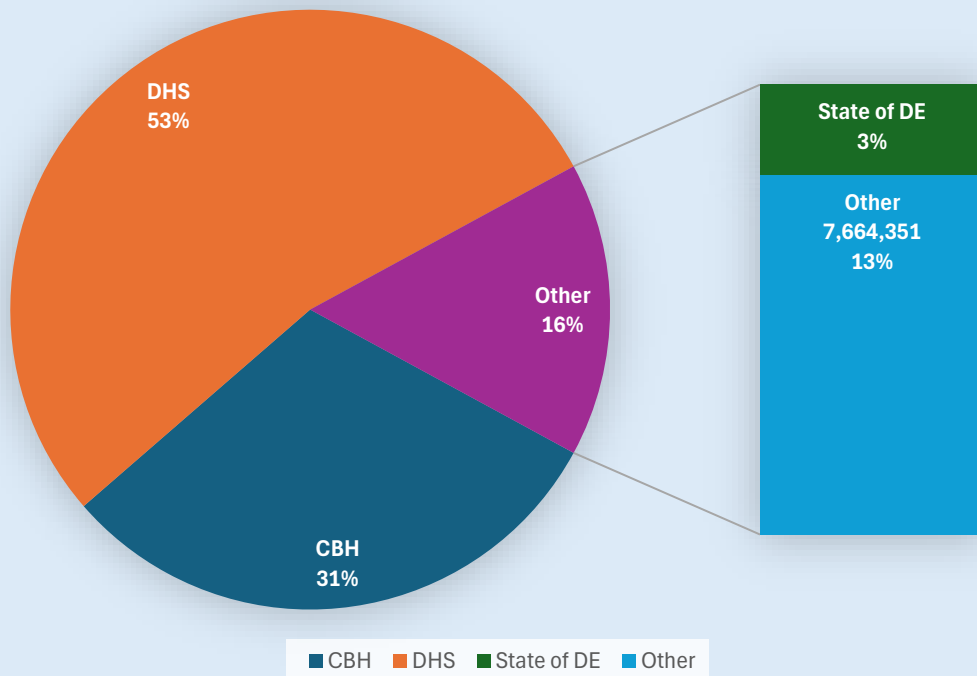
Impact by the Numbers

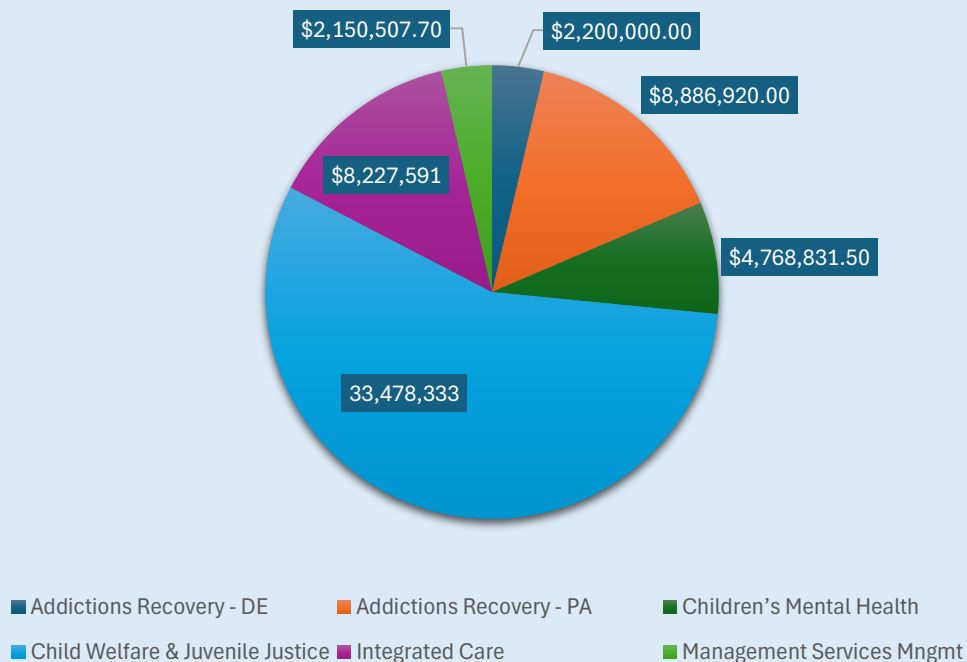
